

**LETTER OF UNDERTAKING REGARDING COMPLIANCE WITH THE  
ENGINEERS AND GEOSCIENTISTS ACT, RSBC 1996, c.116 AS AMENDED**

**WHEREAS:**

The Association of Professional Engineers and Geoscientists of British Columbia ("APEGBC") and Alexander Don Cameron agree to the following statement of facts:

- I. It is the mandate of APEGBC under the *Engineers and Geoscientists Act* (the "Act") to protect the public interest in British Columbia in the practices of professional engineering and professional geoscience, including in terms of stopping unauthorized practices of professional engineering or professional geoscience.
- II. In March 2014, Mr. Cameron ceased in being a member of APEGBC due to his failure to pay his APEGBC practice fee for the year 2014.
- III. In March 2014, APEGBC sent correspondence to Mr. Cameron's email address and his last recorded postal address advising him that he had ceased in being a member of APEGBC and that he was no longer licensed to practice professional engineering in British Columbia.
- IV. It is Mr. Cameron's position that he did not receive APEGBC's correspondence because he had changed his email and postal addresses but had not informed APEGBC of those changes.
- V. During the period from March 2014 to May 2015 (the "Material Period"), Mr. Cameron was prohibited under the Act from engaging in the practice of professional engineering or acting as a professional engineer.
- VI. During the Material Period, Mr. Cameron engaged in unauthorized practices of professional engineering in British Columbia, including by formally signing and sealing two engineering documents purportedly as someone filling the office of and acting as a professional engineer.
- VII. Subsequent to the Material Period, Mr. Cameron's membership in APEGBC was reinstated.

**THEREFORE:**

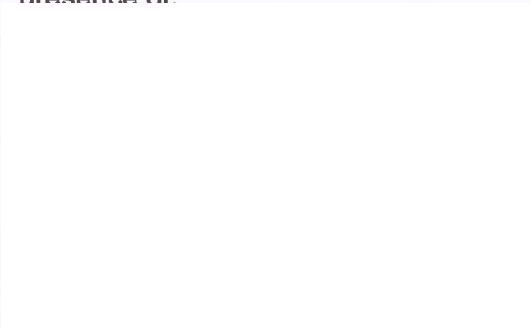
In recognition of the time, effort and expense involved for Mr. Cameron to go through an enforcement procedure and the risk of being liable to pay up to \$25,000 in exemplary damages to APEGBC for past instances of unauthorized practice of professional engineering, and in consideration of APEGBC not commencing a legal proceeding in the Supreme Court of British Columbia against Mr. Cameron in respect of his conduct as set out at paragraph VI. above, Mr. Cameron agrees to this Letter of Undertaking and the following terms:

1. I, **Alexander Don Cameron**, understand that if I fail to pay the annual practice fee or other fees imposed under the Act or the APEGBC Bylaws, my membership in APEGBC may be cancelled pursuant to section 21.2 of the Act.
2. I will promptly inform APEGBC of any future changes to my contact information, unless I intend to cease in being a member of APEGBC, in which case, I will immediately:
  - (a) cease and desist from practising professional engineering in British Columbia;
  - (b) cease and desist from acting in any manner that might lead any person to believe that I am authorized to fill the office of or act as a professional engineer in British Columbia; and
  - (c) deliver to the offices of APEGBC all of my professional engineer's stamps that were issued to me by APEGBC.
3. I understand and accept that this Letter of Undertaking may be published in *Innovation*, and on APEGBC's website, and in such other places and in such manner as APEGBC deems appropriate.
4. I agree that APEGBC may refer to this Letter of Undertaking in any legal proceeding against me, in the event that I breach any of the terms of this Letter of Undertaking.
