- 1. An industry is planning a 50% expansion, but they do not have any more land available for treating their wastewater. The options of acquiring land nearby or relocating are not available. You are their environmental consultant. Identify in point form how you would devise a plan of action.
- 2. Identify in tabular form the important process design variables for:
  - 2.1 a conventional Activated Sludge Plant
  - 2.2 a secondary settling tank
  - 2.3 a membrane separator
  - 2.4 an aerobic digester
  - 2.5 an anaerobic digester
  - 3. A wiget manufacturing industry is being built. They must treat their production wastewater. You have been retained as their environmental consultant. Outline in point form your proposal of addressing this challenge. How would you go about getting the information you need to arrive at waste generation rates?
  - 4. How do you manage biomedical wastes? Differentiate between liquid and solid wastes.
  - 5. You are asked to advise on a management strategy for waste pharmaceutical products. In point form list the steps you would take. Are there any treatment options? If so, identify them in point form.
  - 6. A particular industrial waste contains a bio-inhibitory compound. You have determined that biological treatment would be the best process option if this bio-inhibitory compound were not present. Identify, and discuss in point form how you would handle this problem.
  - 7. What are the minimum nutrient requirements for biological treatment?
  - 8. Under what circumstances would you select a physical-chemical wastewater treatment process train to treat an industrial waste?

- 3 10. Name 3 common strategies to minimize the improper disposal of household hazardous waste.
- 5 11. Name 5 strategies you could use to reduce industrial waste strength.
- 6 12. What are the biggest challenges in the management of biomedical waste?

  - 14.1 plug-flow for a biological treatment process would be a good choice.
